

## VOTER REGISTRATION AND VOTING INFORMATION

A person must meet the following requirements to be a registered voter in Indiana: a citizen of the United States; be at least eighteen (18) years of age on the day of the next general or municipal election; live in a precinct continuously for at least thirty (30) days before the next election; and not currently be in prison following conviction of a crime. Voter registration forms are available at the Tippecanoe County and West Lafayette Public Libraries, or register in person at the City Clerk's office, township trustee offices, or the Bureau of Motor Vehicles. If you have a valid photo voter ID you may register to vote on-line.
